4 WHEREAS, The bill contains technical errors that should be
5 corrected; now, therefore, be it

6 RESOLVED by the 82nd Legislature of the State of Texas, That
7 the enrolling clerk of the senate be instructed to make the
8 following corrections:

9 (1) In SECTION 13 of the bill, in amended Section
10 201.401(b), Transportation Code (conference committee report page
11 10, line 3), strike ", outside, or retained".

12 (2) In SECTION 31 of the bill, in added Section
13 223.201(f)(6), Transportation Code (conference committee report
14 page 49, line 9), between "the" and "Highway" insert "State".
